## **Cardinal Newman Catholic Primary School Risk Assessment**

## V7 8th January 2021 – Government's guidance for Restricting Attendance during National Lockdown covering all elements of "System of Controls"

The Governing Body/Trust Board must take ownership of the risk assessment and have an oversight of the principles behind its contents. School Leaders should revisit, update and share their risk assessment with the school workforce and should publish it on their website to provide transparency of approach to parents, carers and pupils. Schools should review and update their wider premises, staff and pupil risk assessments considering the need for relevant revised controls in respect of their conventional risk profile taking into account the implications of COVID-19. Identified Risk	Recommended Controls & Protective Measures	By whom?	Actioned date
National Lockdown	<ul> <li>During the period of National Lockdown, schools should only allow vulnerable children and young children of <u>critical workers</u> to attend. All other pupils and students should not attend and should learn remotely until February half term.</li> <li>Under the National Lockdown, the expectation is that everybody should work from home where possible. All staff attending the school setting should follow the measures set out in the System of Controls of the risk assessment to minimise the risks of transmission.</li> </ul>		
Face Coverings in Communal Areas	<ul> <li>Primary – all staff and visitors will be required to wear a face covering in communal areas of the school.         <ul> <li>Face coverings must not be removed for meetings.</li> </ul> </li> <li>Some individuals are exempt from wearing a face covering. This applies to those who:         <ul> <li>Cannot put on, wear or remove a face covering because of a physical or mental illness or impairment or disability.</li> <li>Speak to or provide assistance to someone who relies on lip reading, clear sound or facial expression to communicate.</li> <li>Children in primary schools and in early years settings.</li> </ul> </li> <li>Every school should take steps to have a small contingency supply available to meet such needs.</li> </ul>		
PPE in specific work areas	<ul> <li>Members of staff can wear PPE (face covering/visor) in their area of work if they feel it is appropriate.</li> <li>In offices where social distancing is not possible, staff should wear a mask.</li> </ul>		
Afterschool Activities Extended School provision and Breakfast Clubs	<ul> <li>Primary - these activities are considered part of the schools childcare offer therefore will continue with risk management processes as detailed below but only for those children eligible to attend school (i.e. children of critical workers)</li> <li>Children ideally should be kept in a group with other children from the same bubble they are in during the school day. At Whizz Kids this will not be possible,</li> </ul>		

	but bubble numbers are very small and children from different WK bubbles will be supervised separately by a socially distanced staff member, ensuring that relevant ratio requirements are met. Advice on protective measures should be followed and put in place for the duration of the national lockdown to ensure you are operating as safely as possible.	
Vulnerable staff and pupils	<ul> <li>Staff and pupils considered to be Extremely Clinically Vulnerable (ECV) i.e. have received a letter should discuss options for working from home with their line manager/ Head.</li> <li>Clinically vulnerable staff can continue to attend school where it is not possible to work from home. While in school they should follow the sector-specific measures guidance to minimise the risks of transmission.</li> <li>Guidance states that ideally adults should maintain 2 metre distance from others and where this is not possible avoid close face to face contact and minimise time spent within 1 metre of others.</li> <li>Staff who identify as clinically vulnerable are to revisit their personal risk assessment with their line manager to ensure the correct level of mitigation is in place.</li> </ul>	
Reducing contact between individuals	<ul> <li>Staff have been reminded that socially distancing on site is crucial to keeping our schools open.</li> <li>Keep group sizes small and maximise the distance between staff, pupils and other people. At CN, bubble sizes are low and we are following the social distancing / bubble procedures in place when the whole school is in the building e.g. playground separation, different toileting times, no planned times when adults cross bubbles (This may be necessary in particular situations but is not routine)</li> <li>All teachers and other staff can operate across different groups. Where staff need to move between groups, they should try and keep their distance from pupils and other staff as much as they can, ideally 2 metres from other adults. This is not always possible with younger children and teachers in our primaries but they can still work across groups if that is needed.</li> <li>Meetings ideally should be held remotely where possible and if in person, limited to 6 people ensuring a 2 metre distance is maintained unless significant</li> </ul>	

	space allows (e.g. using halls etc) At CN staff meetings and key stage meetings are held remotely; DSL meetings held remotely where possible	
Staff who are pregnant	<ul> <li>As per national restrictions, pregnant staff are in the 'clinically vulnerable' category. The school and the individual should follow the advice in the coronavirus (COVID-19) advice for pregnant employees and refer to the school risk assessment for pregnant women.</li> <li>Pregnant women from 28 weeks' gestation, or with underlying health conditions at any gestation, may be at greater risk of severe illness from coronavirus (COVID-19) so working from home should be considered where possible.</li> <li>Increase hand washing and cleaning of frequently touched areas in the workplace and follow the "System of Control" measures.</li> <li>Pregnant women are not advised to be vaccinated against COVID-19</li> </ul>	
First Aid	<ul> <li>Follow HSE guidance on First Aid.</li> <li>Where it is necessary for first aid to be administered in close proximity, those administering it should pay particular attention to sanitation measures immediately afterwards including washing of hands.</li> </ul>	
Estates	<ul> <li>Fire safety management plans should be reviewed and checked in line with operational changes. Checks should include:         <ul> <li>All fire doors are operational at all times</li> <li>Fire alarm system and emergency lights have been tested and are fully operational</li> <li>Carry out fire drills as normal following social distancing as appropriate and make adjustments if necessary to allow for this.</li> </ul> </li> <li>Limited attendance in buildings can lead to water system stagnation due to lack of use increasing the risk of Legionnaires disease. Checks should include:         <ul> <li>Frequent flushing of seldom used outlets</li> <li>Regular water temperature testing and details recorded for follow up.</li> </ul> </li> </ul>

Low awareness to procedures and risk	<ul> <li>Safeguarding and Health &amp; Safety Policies have been reviewed and updated where needed in light of the COVID-19 advice. Updated policies have been shared with relevant staff.</li> <li>Facilities, catering and lettings procedures have been reviewed with reference to specific guidance as published by gov.uk.</li> <li>Staff to receive any necessary training that helps minimise the spread of infection.</li> <li>The school keeps up-to-date with advice issued by Gov.uk</li> <li>Staff to be made aware of the school's infection control procedures in relation to coronavirus. (Xavier guidance available 15/05/2020)</li> <li>Parents are kept aware of the procedures put in place to help keep the children safe in school. Parents are informed that they must <u>not</u> send their child to school if they have Coronavirus (COVID-19) symptoms, or have tested positive in the last 10 days or if another household member develops coronavirus symptoms. In both these circumstances both the parents/carers should call the school to inform the school of this and that they will be following the national <u>Stay at Home Guidance</u></li> <li>Pupils made aware of rules for staying safe in school and what to do if they feel unwell. Any changes to behaviour expectations should be communicated and published via revised school behaviour policy.</li> <li>Staff and pupils are made aware of the process for removing face coverings when pupils and staff who use them arrive at school, and this is communicated clearly to parents and staff.</li> <li>Any cases of illness, including COVID-19 are to be treated with confidentiality.</li> </ul>	SLT Instructions to parents to go out	Initi ally befo re retu rn to scho ol and cont inui ng once scho ol has resu med
Implementing social distancing	<ul> <li>Class groups (bubbles) are organised as described in the 'class or group sizes' in DfE guidelines.</li> <li>Classrooms and other learning environments are organised to maintain space between seats and desks where possible facing forward.</li> <li>The timetable is revised to implement where possible:</li> </ul>	All staff present in school, guided by SLT. <ul> <li>Plan for lessons or activities which limit movement between areas; Use of other areas of the school is minimised but does include toilets, chapel and hall for some activities.</li> </ul>	
<ul> <li>Maximum number of lessons or classroom activities which could take place outdoors;</li> </ul>	
<ul> <li>Break times (including lunch) are staggered if possible so that all children are not moving around the school at the same time; Timetables in place for each key stage to prevent mixing of bubbles.</li> </ul>	
<ul> <li>Drop-off and collection times are staggered if possible; Half hour stagger usually; Jan 21 numbers very low so no stagger but social distancing maintained</li> </ul>	
<ul> <li>Parents' drop-off and pick-up protocols are planned so that they minimise adult to adult contact; one way system, parents come on site for minimal time and must social distance</li> </ul>	
<ul> <li>Small groups of children are together throughout the day and must avoid mixing with larger groups of children.</li> </ul>	
<ul> <li>Unnecessary items are removed from classrooms and other learning environments where there is space to store it elsewhere</li> </ul>	
<ul> <li>Soft furnishings, soft toys and toys that are hard to clean (such as those with intricate parts) are removed;</li> <li>Cohorts are kept together where possible and children and young people are in the same small groups at all times each day, and different groups are not mixed during the day, or on subsequent days. The only exception for this is for Extended schools and Breakfast clubs for those children eligible to attend school (i.e. children of critical workers) See previous note re Whizz Kids – small bubbles and socially distanced, supervised by socially distanced staff members within ratios.</li> <li>Children and young people use the same classroom or area of a setting throughout the day, with a thorough cleaning of the rooms at the end of the day, and are seated at the same desk. Desks are named and children use the same desk in the same classroom throughout the day, unless the lesson is in the hall or outdoors. Desks and surfaces of the rooms are cleaned at breaktime, lunchtime and after school.</li> <li>Mixing between staff and groups of children in school is minimised by:         <ul> <li>accessing rooms directly from outside where possible; children enter and leave via outside</li> </ul> </li> </ul>

	<ul> <li>Additional alcohol-based sanitiser (that contains no less than 60 percent alcohol) is provided for use where social distancing cannot be adhered to. Supervision of hand sanitiser use will take place due to the risk around ingestion. Younger pupils and pupils with complex needs will continue to be helped to clean their hands properly.</li> <li>Infection control procedures are adhered to as much as possible in accordance with the DfE and PHE's guidance.</li> <li>Sufficient amounts of soap (or hand sanitiser where applicable), clean water, paper towels and waste disposal bins are supplied in all toilets and kitchen areas.</li> <li>Bar soap is not used – liquid soap dispensers are installed and used instead.</li> <li>Pupils are supervised by staff as appropriate when washing their hands to ensure it is done correctly, where necessary.</li> <li>Pupils do not share cutlery, cups or food.</li> <li>All utensils are thoroughly cleaned before and after use.</li> <li>Cleaners are employed by the school to carry out daily, thorough cleaning that follows national guidance and is compliant with the COSHH Policy and the Health and Safety Policy.</li> <li>The SBM arranges enhanced cleaning to be undertaken where required – advice about enhanced cleaning protocols is sought from the local health team. Prevention Advanced Cleaning	<ul> <li>Consider planning for toilets. Different groups do not need allocated toilet blocks, but toilets will be cleaned as frequently as possible, ideally twice a day. Schools must avoid different groups using the toilet at the same time where ever possible and limit the number of children using the toilet at the same time. Toilets all cleaned twice a day and each year group is allocated a specific toilet block to use.</li> <li>Pupils will be encouraged to clean their hands thoroughly after using the toilet.</li> <li>The COVID-19: cleaning of non-healthcare settings guidance is followed. Outdoor playground equipment should be cleaned more frequently. This includes resources used inside and outside by wrap around care providers as set out in the School Lettings Policy/Contract.</li> </ul>	All staff present in school, guided by SLT. are unwell with COVID-19 symptoms	<ul> <li>Staff and other adults do not come into the school if they have coronavirus (COVID-19) symptoms, or have tested positive at least in the last 10 days, and anyone developing those symptoms during the school day is sent home. All schools must follow this process and ensure all staff are aware of it.</li> <li>If anyone in the school becomes unwell with recognised COVID-19 symptoms, they are sent home and advised to follow 'stay at home' guidance for households with possible or confirmed coronavirus COVID-19 infection'. They should arrange to have a test and inform the school the response as soon as available. Other members of their household (including siblings) should self-isolate for 10 days from when the symptomatic person first had symptoms.</li> <li>Any pupil who displays signs of being unwell is immediately referred to the designated member of staff. While waiting to be collected, children will be supervised in an empty room/medical room to ensure social distancing is maintained. A window should be opened for ventilation.</li> <li>PPE will be worn by staff caring for the child while they await collection if a distance of 2 metres cannot be maintained (such as for a very young child or a child with complex needs). More information on PPE can be found in the safe working in education, childcare and children's social care settings, including the use of personal protective equipment PPE guidance.</li> <li>Any members of staff who have helped someone with symptoms and any pupils who have been in close contact with them do not need to self-isolate unless they develop symptoms themselves (in which case they should arrange a test) or if the symptoma and any pupils who ther pupils and as</li> </ul>	guided by SLT. 	<ul> <li>information on PPE can be found in the safe working in education, childcare and children's social care settings, including the use of personal protective equipment PPE guidance.</li> <li>Any members of staff who have helped someone with symptoms and any pupils who have been in close contact with them do not need to self-isolate unless they develop symptoms themselves (in which case they should arrange a test) or if the symptomatic person subsequently tests positive or they have requested to do so by NHS Test &amp; Trace.</li> <li>Pupils displaying symptoms of coronavirus should not come in to contact with other pupils and as few staff as possible, whilst still ensuring the pupil is safe.</li> <li>The relevant member of staff calls for emergency assistance immediately if the pupil's symptoms</li> </ul>		
	<ul> <li>Worsen.</li> <li>The parents of an unwell pupil are informed as soon as possible of the situation by a relevant member of staff.</li> <li>Areas used by unwell pupils who need to go home are thoroughly cleaned once vacated. The Infection Control Policy and COVID-19: cleaning of non-healthcare settings guidance to be followed to clean the area.</li> <li>If unwell pupils are waiting to go home, they are instructed to use different toilets to the rest of the school to minimise the spread of infection. If this is not possible, toilets are to be cleaned and disinfected using the standard cleaning products immediately after use before being used by anyone else.</li> </ul>		

	<ul> <li>Everyone will wash their hands thoroughly for 20 seconds with soap and running water or use hand sanitiser after any contact with someone who is unwell. See the COVID-19: cleaning of non-healthcare settings guidance.</li> <li>In an emergency, call 999 if someone is seriously ill or injured or their life is at risk. First aid can be administered however, strict hygiene measures (hand washing etc.) should be carried out as soon as possible after. PPE and class-based first aid kits available for each bubble.</li> <li>Any medication given to ease the unwell individual's symptoms, e.g. paracetamol, is administered in accordance with the school's policy.</li> <li>Members of staff displaying symptoms of COVID-19 will report to SLT and follow advice given.</li> <li>If a member of staff or child subsequently receives a positive test result for COVID 19, they should inform the school office as soon as possible.</li> <li>The school will liaise with MAT Leadership to coordinate response –i.e. phoning DFE Helpline on 0800 046 8687 who will provide initial guidance and escalate to public health authorities to work with the school on Test and Trace process.</li> <li>If the staff member or student test negative and no longer have symptoms similar to coronavirus (COVID-19), they can stop self-isolating and return to school. In normal circumstances, no proof of negative test is needed.</li> <li>In the event that school and parents disagree that a child may be suffering from COVD-19, school can refuse to allow a child to attend until a negative test has been provided in order to protect other pupils and staff from possible infection. This will be carefully considered in light of current public health advice.</li> </ul>	
Managing risk for vulnerable staff	<ul> <li>Clinically vulnerable staff can continue to attend school where it is not possible to work from home. While in school they should follow the sector-specific measures guidance to minimise the risks of transmission.</li> <li>Guidance states that ideally adults should maintain 2 metre distance from others and where this is not possible avoid close face to face contact and minimise time spent within 1 metre of others.</li> <li>Any clinically vulnerable adults are to have completed the XCET vulnerable staff risk assessment, located on the website and to have discussed their specific needs with a member of SLT and these should be reviewed regularly if the situation changes Clinically vulnerable pupils to be discussed with SLT and a specific RA to be drafted. Parents to be encouraged to support and contribute to this process.</li> <li>In the case of local restrictions being introduced, vulnerable staff and students will be subject to further risk assessment consideration</li> </ul>

	<ul> <li>If staff or pupils cannot maintain distancing, particularly with younger pupils, the risk is reduced by keeping pupils in smaller class sized groups.</li> </ul>		
	<ul> <li>Staff should only move between bubbles when absolutely necessary. Where staff need to move between classes and year groups, where possible they should try and keep their distance from pupils and other staff as much as they can, ideally 2 metres from other adults and wear a face covering. The only staff regularly moving between bubbles are PPA and cover staff. SLT avoid being within two metres of children from different bubbles where possible.</li> </ul>

	At Cardinal Newman, we recognise the importance of music for children's mental health and within the curriculum and we balance this need with the need to maintain safe practices. It is clear that air flow is important to prevent build-up of aerosol transmission and the school's outside doors and classroom doors are all open allowing good air flow around the building. Children will sing within their bubble for short periods (1 hymn) during collective worship and "Signing" hymns will be used sometimes instead of singing. Where possible, children's singing in music lessons will take place in the school hall (high-ceiling) with a class sized bubble and children well-spaced. Children will all face forwards and never be face to face when singing. Background music will be very low to prevent children paoding to sing "over" the backing track
