2. JOB PURPOSE

To actively work and participate under the direction of the Club Supervisor to provide safe high quality play for children and young people aged 4 – 12 years of age.

To build links and work in partnership with parents, carers and professionals to promote the well being of the children.

3. PRINCIPAL ACCOUNTABILITIES:

- i. To support the Supervisor in the directed planning and implementation of the daily activities of the Club to ensure children's needs are met and when required, supervise the safe escorting of children to ensure their wellbeing at all times.
- ii. To work with staff to maintain the Club to an agreed standard of cleanliness and hygiene and to advise the Club Supervisor of any concerns e.g. regarding children, parents or the safety of equipment, preserving confidentiality as necessary.
- **iii.** To support the Club Supervisor in ensuring that all relevant records are maintained and attend staff meetings and training sessions as required.
- iv. To undertake other duties and responsibilities of an equivalent nature as determined by the Club Supervisor.
- **v.** To be aware of and to implement national and local guidelines in order to safeguard and promote the well being of children.

4. WORK CONTEXT

The government are looking at ways in which childcare provision can be extended from the 'traditional school' environment. Introducing Breakfast/After School Clubs is one way in which they are achieving this.
